

USE

The Dahl Engineering docking locking set is solely to be used together with vehicle that features a professionally mounted Dahl Engineering < *www.dahlengineering. dk* > locking unit.

This product serves for automatic locking down of a wheelchair during the transport of people inside a motor vehicle.

ACCEPTANCE

All products are checked by us for faults and packed in special boxes.

- However, we ask you to check the product for possible transport damage as soon as you receive it preferably in the presence of the carrier.
- The packaging of the product should be stored for a further transport that might become necessary.

LIFE SPAN

We estimate an average life span for this product of about 5 years, as far as the product is used within its scope of intended application. In case of an accident of the transport vehicle during use, the product has to be replaced.

The life span of your product depends upon the frequency of use, the application environment and care.

The indicated lifespan does not constitute additional guarantee.

SCOPE OF DELIVERY

Scope of delivery Dahl

(as part of the attachment inside a motor vehicle)

- (1) 1x Locking plate
- (2) 1x Distance washer
- (3) 3x Counter sunk screw
- (4) 2x Counter sunk screw long

Scope of delivery Meyra

- (5) 6x Countersunk screw M8 x 25
- (6) 1x Attachment plate (only on Code 352, without Lift)
- (7) 1x Adapter plate
- (8) 1x Clamping block
- 1x Assembly and user manual

ASSEMBLY INSTRUCTIONS

Execution of he following assembly is to be done by a professionally qualified person.

More detailed information to the assembly advice of the docking-station can be found on the website:

Safety information

For assembly, the electric wheelchair is to be switched off and secured against unintentional rolling movements.

The main-/battery fuse is to be removed before assembly.

Watch for jamming areas during the complete assembly. – Danger of jamming! Keep the working area clean during the assembly!

Only use the supplied special counter sunk screws for assembly.


Secure the countersunk screws with Loctite 222.


Observe 20 - 25 Nm torque!

Code 352, without Lift

Mounting the adapter plate

- 1. For assembly of the adapter plate (7) insert the attachment plate (6) into the profile tube (a).
- 2. Connect the adapter plate (7) and the attachment plate (6) with 4x countersunk screws (5).
- 3. Place the clamping block (8) onto the adapter plate (7) and fasten with 2x countersunk screws (5).





Code 27, with Lift

Mounting the adapter plate

- 1. Screw the adapter plate (7) with 4x countersunk screws (5) underneath the bracket of the lifting cylinder.
- 2. Place the clamping block (8) onto the adapter plate (7) and fasten with 2x countersunk screws (5).

Mounting the docking set

For the correct ground clearance of 70 mm, assembly is to be carried out including the actual weight of the user.


 If required a corresponding distancer
 (2) is to be requested from < www. dahlengineering.dk >.


Only use the supplied special counter sunk screws for assembly.

Secure the countersunk screws with Loctite 222.

Observe 20 - 25 Nm torque!

- 1. Screw the, in driving direction forward facing countersunk screws (3), with the locking plate (1) slid on and the distancer washer (2) from the bottom into the adapter plate (7).
- Screw the two long countersunk screws
 (4) from the bottom into the clamping block (8).
- 3. Check and ensure the secure seat of the docking set in combination with the assembly within the motor vehicle.





Re-establishing driving condition

- 1. Swivel down the seat unit.
- 2. Insert the battery fuse

USER MANUAL

Safety information

Watch for the little ground clearance caused by the mounted docking set. – Danger of accident!

Therefore observe < Technical data on page 7 >.

For transport of handicapped people inside a motor vehicle observe document < Sicherheit mit Meyra-Rollstühlen, auch bei der Beförderung im Kraftfahrzeug > on our website < www.meyra.com >.

Only drive the wheelchair with a mounted docking set into a locking unit of Dahl Engineering.


Before use make sure that the product is functional. – Danger of accident!

Do not use a loose locking plate for fastening the wheelchair. – Increased danger of accidents!

A correct locking down of the wheelchair with the docking station can only be achieved with the weight of the user.

The user must be secured with a permitted strap-retaining system.

MEYRA will not accept liability for damages caused by unattended children in combination with the product!



Locking down the wheelchair

A control diode will light up on the operating module of the docking station when the wheelchair is locked down correctly.

Further information to the Dahl docking-station can be found on the website: < www.dahlengineering.dk >.

In order to lock the docking-station move the wheelchair straight and centred over the locking unit (1) on the floor of the motor vehicle.

A warning tone sounds if the wheelchair is **not** locked down correctly and a warning light appears on the operating module of the docking-station.

Unlocking the wheelchair

To unlock the wheelchair, first press the release key on the operating module of the docking-station, then move the wheelchair slowly backwards out of the locking unit (1) on the floor of the motor vehicle.

Cleaning

For cleaning it is recommended to use soap-solution. The detergent should in any case have a PH-value of no less than 6 (neutral cleanser).

Do not use any detergents that contain solvents.

Repairs

Use only original spare parts. Make use of the service of your specialist dealer.


